Values:


- ITAM Champions: We know the business value ITAM brings, and we want to inspire others so they too can benefit.

ISO/IEC 19770-1 Certification Scheme

In February 2023, we brought to market the world's first, globally-recognised and accepted <u>ISO/IEC 19770-1</u> <u>certification scheme</u>! Organisations can now receive unrivalled recognition for their ITAM practice.

Our Committee of Experts – comprised of roughly 100 ITAM professionals from 20 countries and 30+ industries with more than 870+ years of combined ITAM/SAM experience – drafted the scheme and determined how conformity would be measured. We also engaged with NEN, the Royal Dutch Standardization Institute, for support and guidance. Moving forward, this committee will update the scheme every five years to keep it relevant, accepted, and in line with ISO 19770-1 developments and other related standards.

This truly is a certification scheme for, and of, the ITAM community.

During February, we also announced the first two organisations (ever) to receive ISO/IEC 19770-1 certification: HDI Group and Softline Group Northern Europe.

ISO/IEC 19770-1 Practitioner Course

In March 2023, we held the first ISO/IEC 19770-1 Practitioner course. This course focuses on the skills needed to help end-user organisations successfully navigate an ISO/IEC 19770-1 audit and achieve certification. It was developed in partnership with BC Academy (the training institute of Brand Compliance – the certification scheme auditor).

A mixture of end-user customers, consultants, and partners attended the inaugural course. Each passed the exam, gaining an ISO/IEC 19770-1 Practitioner certificate. It was an interactive group, and we gained a NPS score of 91.7 and great feedback on how to further enhance the course material.

Events and Resources

During the last financial year, we held two, well-attended Certification Scheme webinars, including one with Brand Compliance, the scheme's auditor. These digital events enabled us to speak about the scheme and enabled ITAM professionals to ask questions directly to the official auditor.


Community Growth
